Official Rules

The Become a -196™ MilliYENaire Sweepstakes ("Sweepstakes") is sponsored by Jim Beam Brands Co. (the "Sponsor"). The Sponsor's address is 222 W Merchandise Mart Plaza, Chicago, IL, 60654. The Sweepstakes begins at 12:00:01 a.m. Eastern Time ("ET") on May 1, 2026, and ends at 11:59:59 p.m. ET on September 30, 2026 ("Sweepstakes Period"). The computer clock of Sponsor is the official time-keeping device in the Sweepstakes, and the Sponsor may also rely on the time processing functions of third parties. Sponsor shall have the sole discretion in determining the timeliness of any action or inaction related to this Sweepstakes.

The Sweepstakes consists of two (2) separate components, a regional component ("Regional Component") and a national component ("National Component"), with each component being open to participation for Entrants residing in specific areas (each an "Eligibility Area") in the United States, all as further detailed in Table A below:

- 1. ELIGIBILITY:** The Sweepstakes is open only to individuals who: (a) are 21 years of age or older at the time of entering the Sweepstakes; (b) agree to be bound by the terms of these Official Rules; and (c) submit a valid Entry (as defined below) (each such individual, an "Entrant" or "you"). In addition, each Regional Component of the Sweepstakes is only open to Entrants who are legal residents of the applicable eligible States as set out in Table A above. This Sweepstakes is **not open** to Entrants who:

(i) are employees, officers, directors, agents and representatives of the Sponsor or any entity which is involved in any aspect of the creation, production, operation, execution or fulfillment of the Sweepstakes, (such entities, collectively, the "Sponsor Parties"), or any alcohol beverage licensees (including alcohol beverage suppliers, wholesalers, distributors or retailers); (ii) are immediate families (defined as parents, children, siblings, domestic partner, spouse and their respective spouses, regardless of where they reside) or household members (defined as those people who share the same residence at least three (3) months a year) of such individuals listed in clause (i) above); (iii) are prohibited by applicable law from entering the Sweepstakes; or (iv) do not meet any of the eligibility requirements set forth above.

Each completed and validly submitted Registration Form will result in the eligible Entrant receiving one (1) "Entry" into the applicable Drawing (defined in Section 3) as follows:

- An Entrant who is a resident of a "Regional Component Eligibility Area" (as set out in Table A above) and who Enters the Sweepstakes during the Sweepstakes Period, will receive: (a) one (1) Entry into the Regional Drawing (defined in Section 3) for the applicable Regional Component Eligibility Area; **and** (b) one (1) Entry into the National Drawing (defined in Section 3).

You will receive a response which will contain a link to download a QR reader for your specific device. Check with your wireless service provider for details on these and other applicable charges. Entrants are solely responsible for any such wireless charges. Not all wireless carriers participate.

Entry Limits: The following limits apply throughout the Sweepstakes Period, regardless of method of Entry.

- a. Entrants who are residents of an Eligibility Area that is a Regional Component Eligibility Area can receive a maximum of (per person, per email address):

All materials submitted become the property of Sponsor and will not be returned. Illegible and/or incomplete Entries and Entries submitted by Entrants who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. 3. WINNER SELECTION; DRAWINGS: There are a total of two (2) drawings (each, a "Drawing") for the Sweepstakes as follows:

- **Regional Drawing:**

On or about October 6, 2026, the Sponsor will randomly select one (1) Grand Prize Winner, from among all eligible Entries received during the Sweepstakes Period from Entrants residing in a Regional Component Eligibility Area (the "Regional Drawing").

- **National Drawing:**

On or about October 6, 2026, the Sponsor will randomly select one (1) Grand Prize Winner, nine (9) First Prize winners and six (6) Second Prize winners from among all eligible Entries received during the Sweepstakes Period from Entrants residing in the National Component States (as set out in "Table A") (the "National Drawing").

Odds of winning a National Prize (defined below) depend on the number of eligible Entries received during the Sweepstakes Period from residents of the National Component States.

4.
