The Promotion begins at 12:01 a.m. Eastern Time ("ET") on July 7, 2025, and ends at 11:59 p.m. ET on November 7, 2025, or such earlier period when all available Zoo Cash payments (defined below) have been distributed ("Promotion Period"). The Qualifying Purchase must be made between 12:01 a.m. ET on July 7, 2025, and 11:59 p.m. ET on October 31, 2025, at any Participating Retailer(s) or online. Receipt Images (as defined below) must be submitted and received between August 1, 2025, at 12:01 a.m. ET and 11:59 p.m. ET on November 7, 2025. The Promotion is administered by Snipp Interactive Inc., (the "Administrator"). The Administrator's address is 6708 Tulip Hill Terrace, Bethesda, Maryland 20816. The computer clock of Administrator is the official time-keeping device in the Promotion, and the Administrator may also rely on the time processing functions of third parties. Administrator shall have the sole discretion in determining the timeliness of any action or inaction related to this Promotion.

- 1.
