# BODYARMOR X 2026 STANLEY CUP FINAL® SWEEPSTAKES & INSTANT WIN GAME

#### Official Rules

The BODYARMOR X 2026 Stanley Cup® Final Sweepstakes & Instant Win Game ("Promotion") is sponsored by BA Sports Nutrition, LLC (the "Sponsor"). The Sponsor's address is 17 - 20 Whitestone Expressway, Suite 500, Whitestone, NY 11357. The Promotion begins at 12:01 a.m. Eastern Time ("ET") on September 1, 2025, and ends at 11:59 p.m. ET on October 31, 2025 ("Promotion Period"). The Promotion is administered by Snipp Interactive Inc. (the "Administrator"), whose address is 20860 N. Tatum Blvd., Suite 300, Phoenix, Arizona 85050. The computer clock of the Administrator is the official time-keeping device for the Promotion, and the Administrator may, in its sole discretion, rely on the time processing functions of third parties. The Administrator shall have sole discretion in determining the timeliness of any action or inaction related to this Promotion.
