### 1. KEY DATES:

The Orville Redenbacher® Promotion Celebrating the Release of *The Mandalorian and Grogu* (the “Promotion”) begins on March 22, 2026 at 12:00:00 a.m. Eastern Time (“ET”) and ends on June 13, 2026 at 11:59:59 p.m. ET (the “Promotion Period”).

### 2. ELIGIBILITY:

THIS PROMOTION IS OPEN ONLY TO INDIVIDUALS WHO ARE LEGAL RESIDENTS OF AND PHYSICALLY LOCATED IN CANADA AND WHO HAVE REACHED THE LEGAL AGE OF MAJORITY IN THEIR JURISDICTION OF RESIDENCE AT THE TIME OF ENTRY. Promotion may only be entered from and within Canada. Employees, representatives and agents (and those with who such persons are living – whether related or not, and immediate family) of Conagra Brands Canada Inc. The Promotion Parties, and each of their respective officers, directors, agents, representatives, successors and assigns (collectively, the “Released Parties”) are not responsible for, and accept no liability whatsoever in relation to, any lost, stolen, delayed, illegible, damaged, misdirected, late or destroyed Requests (all of which are void).

### 6. HOW TO ENTER:

Once you have legitimately obtained a valid UPC Code in accordance with Rule 4, visit [www.orvillecontest.ca](http://www.orvillecontest.ca) (the “Website”) and follow the on-screen instructions to go to the Official Promotion Entry Form (the “Entry Form”). Fully complete the Entry Form with all required information, which includes a requirement to: (i) enter your first name, last name, telephone number, valid email address, retailer where the product was purchased, store location (city and major intersection), as well as complete two-factor authentication by receiving and entering a one-time password (“OTP”) sent to your email address and reading and accepting any required terms and conditions; ii) enter a valid UPC Code legitimately obtained in accordance with these Official Rules; and (iii) signify your agreement that you have read and agree to be legally bound by the terms and conditions of these Official Rules. Once you have fully completed the Entry Form with all required information (including entering your UPC Code in the space provided), follow the on-screen instructions to submit your completed Entry Form (the “Entry”). To be eligible, your Entry must be submitted and received in accordance with these Official Rules. Once your Entry is complete, you will automatically earn one (1) Entry for a chance to win the Grand Prize (See Rule 8).

## 7. VERIFICATION:

All Entries, Requests, Eligible Products and UPC Codes are subject to verification at any time and for any reason. The Contest Administrator reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Contest Administrator – including, without limitation, government issued photo identification): (i) for the purposes of verifying an individual's eligibility to participate in this Promotion; (ii) for the purposes of verifying the eligibility and/or legitimacy of an Entry, Request, Eligible Product, UPC Code and/or other information for the purposes of this Promotion; and/or (iii) for any other reason the Contest Administrator deems necessary, in its sole and absolute discretion, for the purposes of administering this Promotion in accordance with the Contest Administrator's interpretation of the letter and spirit of these Official Rules. Further, the Contest Administrator reserves the right, in its sole and absolute discretion, to request any original UPC Code for the purposes of verification. Failure to provide the proof requested by the Contest Administrator to the complete satisfaction of the Contest Administrator (including, if required, providing the original UPC Code) within the timeline specified by the Contest Administrator may result in disqualification in the sole and absolute discretion of the Contest Administrator. ## 8. THE GRAND PRIZE:

There will be one (1) Grand Prize (the "**Grand Prize**") available to be won, while supplies last. The Grand Prize consists of a trip for the confirmed winner and three (3) Guests (each, a "**Guest**" – subject to the Guest Requirements below) inspired by *Star Wars: The Mandalorian and Grogu* (the "**Experience**"). **IMPORTANT NOTE:** Some of the experiences noted above have specific age, height and/or weight requirements. If the confirmed winner and/or any of their Guests cannot participate in an experience, then that element of the Grand Prize may be forfeited in its entirety and, if forfeited, nothing will be substituted in its place.

On, or about Friday, June 22, 2026 (the "Draw Date") in Toronto, Ontario at approximately 12:00:00 p.m. ET, one (1) eligible entrant will be selected by random draw from among all eligible Entries submitted and received to date in accordance with these Official Rules. The odds of winning the Grand Prize depend on the number of eligible Entries submitted and received in accordance with these Official Rules.

The Contest Administrator or its designated representative will make a maximum of two (2) attempts to contact the eligible winner (using the information provided on the Entry Form) within two (2) business days of the Draw Date. If the eligible winner cannot be contacted as outlined above, or if there is a return of any notification as undeliverable; then they may, in the sole and absolute discretion of the Contest Administrator be disqualified (and, if disqualified, will forfeit all rights to the Grand Prize) and the Contest Administrator reserves the right, in its sole and absolute discretion and time permitting, to randomly select an alternate eligible entrant from among the remaining eligible Entries (in which case the foregoing provisions of this section shall apply to such newly selected eligible winner).
