

DANONE ACTIVIA CHALLENGE CONTEST FULL RULES:

The Danone Activia Challenge Contest & Offer (the "**Program**") is organized by Danone Inc. (the "**Sponsor**") and administered by Snipp Interactive, Inc. ("**Administrator**"). The Program consists of a Contest ("**Contest**") and a Gift with Purchase Offer ("**Offer**"). The Sponsor is responsible for the Program, its organization and these Official Rules & Terms & Conditions (the "**Rules**" and "**Terms**").

- 1. AGREEMENT TO THE RULES & TERMS:** By participating in the Program, each entrant (each entrant referred to as an "**Entrant**", together as the "**Entrants**") unconditionally accepts and agrees to comply with and abide by these Rules & Terms and the decisions of the Sponsor and Administrator, which shall be final and binding in all matters related to the Program.
- 2. PROGRAM PERIOD:** The Program begins at 12:00:00 AM (ET) on December 30, 2024, and ends at 11:59:59 PM (ET) on February 16, 2025 ("**Program Period**", or the "**Contest Period**").
- 3. ELIGIBILITY:** The Program is open only to persons who are who are legal residents legal residents of Canada, who have reached the age of majority in their province of residence at time of entry. Employees of Danone, Inc. and the Administrator, their subsidiaries, affiliates, advertising, contest and other agencies ("**Program Entities**") and their immediate family members (their legal or common-law spouse, siblings, children, parents) and/or those living in the same household of each are not eligible to participate.
- 4. THE PROGRAM:** The Program consists of a promotional offer where an eligible Participant who purchases one (1) or more of Participating Activia Product(s) (defined below) during the Purchase Period from any retail store or online in the Eligibility Area (a "**Participating Retailer**") in one (1) single transaction, is given the opportunity to receive: (A) one (1) \$1 CAD Print-at-Home Coupon (1) (such Coupon, a "**Reward**"), while supplies of Rewards last; and (B) one (1) Entry into the Contest portion of the Danone Activia Challenge Offer and Contest. See Section 6 for how to participate in the Offer. See Section 9 for how to participate in the Contest, including how to enter the Contest without making a Purchase. Limit one (1) Print-at-Home coupon per person for the first verified receipt submitted.

Exhibit A sets out the specific participating products for the purposes of the Offer (the "**Participating Products**").

Purchase of a Participating Product as set out in these Official Rules does not guarantee the receipt of a Reward, and Rewards will only be given out while supplies of Rewards last.

5. OFFER PERIOD; PURCHASE PERIOD AND KEY DATES

To be eligible, qualifying purchases of Participating Products must be made between December 30, 2024, at 12:00:00 am Eastern Time (ET) and February 16, 2025, at 11:59:59 pm ET (the "**Purchase Period**"), at a Participating Retailer. Requests (as defined below) must be submitted and received between December 30, 2024, at 12:00:00 am ET and February 16, 2025, at 11:59:59 pm ET (the "**Offer Period**").

- 6. HOW TO PARTICIPATE:** To take advantage of the Offer, an eligible participant must follow the steps listed below:

(A) Make a Qualifying Purchase of one (1) or more Qualifying Products within one (1) single transaction, from a Participating Retailer, during the Purchase Period;

(B) Take a photograph (png, jpeg, pdf, and tiff file types with a maximum file size of 10MB) of the applicable sales receipt of his/her Qualifying Purchase in its entirety (such photograph, a "**Receipt Image**") identifying the Participating Retailer and date of purchase. Participants are strongly encouraged to remove, obscure or redact out any personal information that appears on the Receipt Image; and

(c) On or before the Offer Closing Date, following the submission method listed below, submit their Receipt Image (such submission, a "Request"):

Visit Program Site to Submit. During the Program Period, visit www.activiachallenge.ca (the "Program Site"), where Participant will receive further instructions on uploading the Receipt Image and registering for the Offer. Complete the registration form by entering true and accurate information in the required fields (including, First Name, Last Name, Street Address, City, State/Province, Zip/Postal Code, E-Mail Address, Phone Number). Follow instructions and submit Receipt Image (including reading and accepting any required terms and conditions) and register for the Offer. **Registering for the Offer is the only way to receive a Reward**, which will be sent to the email address provided during registration, by 48 Hours, after you have been found eligible to receive a Reward. Without the information supplied via registration, we cannot send you your Reward.

IMPORTANT: YOU MUST KEEP YOUR ORIGINAL SALES RECEIPT. Sponsor reserves the right to request from a person the original sales receipt used for the purposes of this Offer for further verification purposes at any time and for any reason.

7. PROCESSING OF SUBMISSIONS AND VERIFICATION

Processing of a Receipt Image will take 48 hours from the time the Receipt Image is received by the Administrator. Once a Participant's Receipt Image is processed, such Participant will be notified via email only if such Receipt Image has been invalidated with a reason why such Receipt Image could not be processed at such time, as determined by the Administrator in its sole and absolute discretion. It is the responsibility of the Participant to check the applicable email account/phone for such notification including in the inbox, spam or junk folders. The Program Entities do not assume any responsibility and are not responsible for electronic communications which are undeliverable for any reason, including (but not limited to) as a result of any form of active or passive filtering of any kind or insufficient space in a participant's mailbox or telephone to receive e-mail messages, or other communications. All Receipt Images become the property of Program Entities and will not be returned. Program is void where taxed, prohibited, or restricted by law. The Sponsor takes no responsibility for any lost, stolen, delayed, illegible, damaged, misdirected, late or destroyed no purchase submissions.

Limit six (6) Entries per Entrant, regardless of method of entry ("an **Entry**" and collectively the "**Entries**").

Standard data charges may apply to entrants who choose to enter the Contest via a mobile device. Please contact your service provider for rates and service plan information prior to participating with your mobile device.

Program Entities are not responsible for lost, late, misdirected, or incomplete data capture. Entries become the property of Sponsor and will not be returned. Program Entities are not responsible for lost, late, illegible, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified,

or for problems of any kind, whether mechanical, human or electronic. Program Entities shall not be responsible for incorrect or inaccurate entry information whether caused by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the processing of the Entries in the Contest. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identification and/or eligibility (in a form acceptable to the Sponsor, including, but not limited to, government-issued photo identification): (i) to verify an individual's eligibility to participate in this Contest; (ii) to verify the eligibility and/or legitimacy of any Entry; and/or (iii) for any other purpose that Sponsor deem necessary, in its absolute discretion, for the administration of this Contest in accordance with Sponsor's interpretation of the letter and spirit of these Rules. Any person who fails to provide such proof to the complete satisfaction of the Sponsor, within the time period specified by the Sponsor, may be disqualified in sole and absolute discretion of the Sponsor. Only the official timekeeping device(s) of the Administrator will determine the time for the purposes of this Contest.

Disqualification. Entrants must comply with the following conditions, or they may be disqualified, and their Entry may be cancelled:

- Entrants must use a valid email address.
- Only six (6) Entries per Entrant will be permitted.
- Entrants must use the same email address at all times during the Contest Period.
- Use of more than one (1) email address will result in automatic disqualification.
- Multiple accounts created by the same Entrant will be disqualified.

12. WINNER SELECTION AND NOTIFICATION: On February 24, 2025, at 2:00 PM (ET), thirty (30) potential prize winners ("**Prize Winner(s)**") will be selected by random draw from all valid Entries received by that date. The draw will be conducted at the Administrator's offices in Detroit, Michigan (U.S.). The prizes will be awarded, provided there are a sufficient number of qualified entries received. Potential Prize winners will be notified by email, phone and/or mail, using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted, or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within forty-eight (48) hours of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected, time permitting. GOVERNING LAW:** Subject to Rule 14, all issues and questions concerning the construction, validity, interpretation, and enforceability of the Rules, or the rights and obligations of Entrants and the Sponsor in connection with the Contest shall be governed by and construed in accordance with the laws of the Province of Quebec and the laws of Canada applicable therein, without regard to conflicts of law principles. Any attempt by an Entrant or any other individual to deliberately damage any website or undermine the legitimate operation of the Contest could be a violation of criminal and civil laws and should such an attempt be made; the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.
