

**DiGiorno Pizza Kickoff Sweepstakes
Official Rules**

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. SWEEPSTAKES IS OPEN TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO U.S. LAW. DO NOT ENTER THIS SWEEPSTAKES IF YOU ARE NOT ELIGIBLE AND LOCATED IN THE 50 UNITED STATES OR DISTRICT OF COLUMBIA.

Sweepstakes Period: DiGiorno Pizza Kickoff Sweepstakes (“Sweepstakes”) begins at 12:00:01 A.M. Eastern Time (“ET”) on January 1, 2024, and ends at 11:59:59 P.M. ET on February 16, 2024 (“Sweepstakes Period”).

Eligibility: The Sweepstakes is open to legal residents of the fifty (50) United States or the District of Columbia, who are at least eighteen (18) years of age, or the age of majority in their state of residence (which is nineteen (19) in Alabama and Nebraska, twenty-one (21) in Mississippi, and eighteen (18) in all other states) at the time of entry. Void where prohibited or restricted by law. Employees of Sponsor, Administrator, Fanatics, Inc. or any of their respective parents, affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production, execution, or distribution of the Sweepstakes (collectively with Sponsor and Administrator the “Sweepstakes Entities”), as well as the immediate family (spouse, parents, and step-parents, siblings and step-siblings, and children and step-children) and household members of each such employee, whether or not related, are not eligible to enter or win.

How To Receive additional entries:

- **Via signing up for Sponsor’s Email Updates:** During the Sweepstakes Period, after submitting a Base Entry, you may obtain one (1) additional entry agreeing to receive emails from the Sponsor by checking the box in the space indicated to provide such consent (“Email Entry”). You can unsubscribe at any time. **Limit one (1) Email Entry per person/email address for the entire Sweepstakes Period.**
- **Via email/refer-a-friend:** During the Sweepstakes Period, after submitting your Base Entry, you may obtain one (1) additional entry by providing the email address of an eligible friend or family member who you would like to refer the Sweepstakes (“Referral Entry”). **Limit one (1) Referral Entry per person/email address for the entire Sweepstakes Period**

As used herein, "Entry" and "Entries" refers collectively to Base Entry/Entries, Email Entry/Entries and Referral Entry/Entries. To be included in the random drawing (as described below), Entries must be received by the end of the Sweepstakes Period.

Regardless of Entry method, limit forty-nine (49) total Entries per person/email address for the entire Sweepstakes Period. Entries in excess of any entry limitation stated herein will be void. If it is discovered by the Sponsor or Administrator (using any evidence or other information made available to or otherwise discovered by the Sponsor or Administrator) that any person has attempted to use multiple names, multiple identities, and/or any automated, macro, script, robotic or other system(s) or program(s), and/or any other means not in keeping with the Sponsor's or Administrator's interpretation of the letter and spirit of these Official Rules to participate in, or to disrupt this Sweepstakes then such person may be disqualified from the Sweepstakes in the sole and absolute discretion of the Sponsor and all associated Entries will be forfeited.

Entrants who do not follow all of the instructions, do not provide the required information on the entry form, or do not abide by these Official Rules or other instructions of Sponsor and/or Administrator may be disqualified.

Drawings/Winner Notifications: There will be one (1) random drawing held in the Sweepstakes. On or about February 19, 2024, Administrator will randomly select one (1) potential Grand Prize A winner (a "Grand Prize A Winner"); one (1) potential Grand Prize B winner (a "Grand Prize B Winner", and with the Grand Prize A Winner, each sometimes a "Grand Prize Winner", and together the "Grand Prize Winners"); and one thousand (1,000) potential first prize winners (each a "First Prize Winner"); from among all eligible Entries received during the Sweepstakes Period. Odds of winning depend on the total number of eligible Entries received during the Sweepstakes Period. Grand Prize Winners are considered a "potential" winner pending verification of eligibility and compliance with these Official Rules. Administrator will make two (2) attempts within a twenty-four (24) hour period to notify each potential Grand Prize Winner at the email address submitted at the time of entry. Potential Grand Prize Winners must respond within forty-eight (48) hours of notification. Failure of a potential Grand Prize Winner to respond within forty-eight (48) hours of notification may result in disqualification and an alternate potential Grand Prize Winner may be selected. Potential Grand Prize Winners will be required to sign a winner's agreement and release, and where applicable have their guest(s) sign an agreement and release ("Winner Release") and return it by the date specified in Administrator's notification, or the applicable Grand Prize will be forfeited in its entirety and another potential Grand Prize Winner may be selected. The potential Grand Prize Winners will also be required to execute and return an IRS Form W-9 (and will receive a subsequent 1099 IRS Form for the actual retail value of Grand Prize) along with the Winner Release and any other documentation that Sponsor and Administrator may require and return it by the date specified by Sponsor or Administrator in the notification, or the applicable Grand Prize may be forfeited in its entirety and another potential Grand Prize Winner may be selected. If potential Grand Prize Winner is found not to be eligible or not in compliance with these Official Rules, or if prize notification or any portion of the Grand Prize is returned as undeliverable, potential Grand Prize Winner may be disqualified and an alternate potential Grand Prize Winner will be selected. Sponsor and Administrator are not responsible for any change of email address or phone number of any entrant. Sponsor expressly reserves the right to delay the announcement of the Grand Prize Winner and any First Prize Winners for any reason it deems necessary.

Chest Freezer (\$549.00) wrapped with DiGiorno branding; one hundred (100) DiGiorno Pizzas (\$600.00); one (1) Sonos Arc Soundbar with Dolby Atmos Google Assistant and Amazon Alexa Soundbar (\$899.99); one (1) Ooni Indoor Electric Pizza Oven (\$999.99); one (1) Kegco 24” Wide Single Tap Kegeerator with DiGiorno tap handle (\$770.00); one (1) One Thousand Dollar (\$1,000) Fanatics eGift Card; one (1) One Thousand Dollar (\$1,000) Walmart eGift Card. ARV of Grand Prize B is \$12,049.97

One Thousand (1,000) First Prizes (each, a “First Prize”): one (1) One Hundred Dollar (\$100) Fanatics eGift Card. ARV of each First Prize is \$100. ARV of all First Prizes is \$100,000.00

Grand Prize A Additional Terms:

Grand Prize A Winner and Guest must be available to travel to Detroit, MI on dates specified by Sponsor. No alternate travel dates are available. In the event Grand Prize A Winner cannot travel on the dates designated by Sponsor, Grand Prize A Winner may be disqualified, and the Grand Prize A may be awarded to an alternate potential Grand Prize A Winner provided sufficient time remains prior to the travel.
