The Sweepstakes is administered by Snipp Interactive Inc (the "**Administrator**"). The Sweepstakes begins at 12:00:01 a.m. Central Daylight Time ("**CDT**") on April 3, 2026, and ends at 11:59:59 p.m. CDT on September 7, 2026 ("**Sweepstakes Period**") and comprises of twenty-three (23) separate weekly entry periods (each a "**Weekly Entry Period**"), as outlined in Table A below. The computer clock of Administrator is the official time-keeping device in the Sweepstakes, and the Sponsor may also rely on the time processing functions of third parties. Sponsor shall have the sole discretion in determining the timeliness of any action or inaction related to this Sweepstakes.

- 1. ELIGIBILITY:** The Sweepstakes is open only to individuals who: (a) are legal residents of the fifty (50) United States and the District of Columbia (the "**Eligibility Area**"); (b) eighteen (18) years of age or older (or 19 years of age or older if a resident of AL or NE, or 21 years of age or older if a resident of MS) or older at the time of entering the Sweepstakes; (c) agree to be bound by the terms of these Official Rules; and (d) submit a valid Entry (as defined below) (each such individual, an "**Entrant**" or "**you**"). This Sweepstakes is **not open** to Entrants who: (i) are employees, officers, directors, agents and representatives of the Sponsor, the Administrator, United States national soccer team (USMNT) and U.S. Soccer Federation or any other entity which is involved in any aspect of the creation,

production, operation, execution or fulfilment of the Sweepstakes, (such entities, collectively with the Sponsor and the Administrator, the "**Sweepstakes Parties**"); (ii) are immediate families (defined as parents, child, sibling, domestic partner, spouse and their respective spouses, regardless of where they reside) or household members (defined as those people who share the same residence at least three (3) months a year) of such individuals listed in clause (i) above); (iii) are prohibited by applicable law from entering the Sweepstakes; or (iv) do not meet any of the eligibility requirements set forth above.

2.1 To Enter Via Online by registering on the Sweepstakes Site: Entrants must: (i) visit the Sweepstakes Site during the Sweepstakes Period; (ii) complete all required fields (no PO Boxes accepted) on the Sweepstakes Entry form including confirming eligibility and agreeing to the Official Rules and Sponsor's Privacy Policy; and (iii) submit the registration as instructed to receive one (1) entry into the Sweepstakes. Only fully completed entry forms are eligible.

- (a) **Bonus Entries via the Online Entry Method:** Entrants who enter the Sweepstakes by registering on the Sweepstakes Site, may receive up to two (2) bonus Entries by making a Qualifying Purchase during the Sweepstakes Period. A "**Qualifying Purchase**" means buying one (1) or more "Participating Products" in a single transaction from any "Participating Retailer" in the Eligibility Area. Each Weekly Drawing will be conducted shortly after the close of the applicable Weekly Entry Period. The final Weekly Drawing will correspond to Weekly Entry Period 23 (September 5–September 7, 2026), which is a shortened entry period. The number and type of prizes to be awarded are outlined in Section 6 below. A total of three thousand seven hundred and eighty-six (3,786) prizes will be awarded. The odds of winning a prize depend on the number of eligible Entries received for each weekly drawing.
