

Ferrara Trolli Gaming Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING THE SWEEPSTAKES.

INTERNET ACCESS AND A VALID E-MAIL ACCOUNT ARE REQUIRED. A mobile device may also be used to participate. Standard data and messaging rates may apply to participate in the Sweepstakes via a mobile device. Please contact your service provider for pricing and service plan information and rates before mobile device participation.

BY SUBMITTING AN ENTRY TO THIS SWEEPSTAKES DURING THE SWEEPSTAKES PERIOD, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. AMONG OTHER THINGS, THIS CONTRACT INCLUDES INDEMNITIES FROM YOU TO THE SWEEPSTAKES ENTITIES AND A LIMITATION OF YOUR RIGHTS AND REMEDIES, AND A REQUIREMENT TO ARBITRATE ALL DISPUTES.

ODDS OF WINNING A SWEEPSTAKES PRIZE WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED. VOID OUTSIDE THE ELIGIBILITY AREA (DEFINED BELOW), AND WHERE PROHIBITED OR RESTRICTED BY LAW.

The "FERRARA TROLLI GAMING SWEEPSTAKES" (the "**Sweepstakes**") is organized by Ferrara Candy Company, 404 W Harrison St, Ste 650, Chicago, IL 60607 (the "**Sponsor**") and administered by Snipp Interactive Inc., 6708 Tulip Hill Terr, Bethesda, MD 20816 (the "**Sweepstakes Administrator**"). The Sponsor is responsible for the Sweepstakes, its organization, and these Official Rules (the "**Rules**").

- 1. AGREEMENT TO THE RULES:** By participating in the Sweepstakes, each entrant (each entrant is referred to as an "**Entrant**", together as the "**Entrants**") unconditionally accepts and agrees to comply with and abide by these Rules and the decisions of the Sponsor and Administrator, which shall be final and binding in all matters related to the Sweepstakes.
- 2. SWEEPSTAKES PERIOD:** The Sweepstakes begins on March 1, 2025, at 12:00:00 a.m. Eastern Time ("ET") and ends on August 31, 2025, at 11:59:59 p.m. ET (the "**Sweepstakes Period**").
- 3. ELIGIBILITY:** This Sweepstakes is open to all legal residents of, and physically located within, the fifty (50) United States, the District of Columbia and Puerto Rico (the "**Eligibility Area**") who are at least thirteen (13) years of age, at time of entry. Employees, agents, representatives, officers and directors of the Sponsor and each of their respective subsidiaries, affiliated companies, parent corporations, advertising and promotion agencies, sponsors, suppliers of services related to this Sweepstakes, or of any other party directly associated with the holding of the Sweepstakes ("**Sweepstakes Entities**"), as well their immediate family members (brothers, sisters, children, father, mother), their legal or common-law spouse, and any persons residing with these employees, agents, representatives, officers and directors (whether related or not) are not eligible to participate. ELIGIBLE ENTRANTS UNDER THE AGE OF 18 MUST HAVE PERMISSION FROM A PARENT/LEGAL GUARDIAN TO PARTICIPATE IN THE SWEEPSTAKES.
- 4. HOW TO ENTER: NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

There are two (2) ways to enter the Sweepstakes (each an "**Entry**") for a maximum of forty (40) Entries per Entrant for the entire Sweepstakes Period, regardless of the method of Entry, as follows:

- (a) Purchase Option:** Enter the Sweepstakes by purchasing one (1) or more participating Trolli product as set out in Appendix A, below (each, a "**Participating Product**"), between March 1, 2025 and August 31, 2025 (the "**Purchase Period**") from any participating retailer or online (such online or physical store, a "**Participating Retailer**" and such purchase, a "**Qualifying Purchase**") and thereafter during the Sweepstakes Period : (i)

registering online at the website located at www.Trolli.com/Elgato (the "**Website**"), and thereafter following the instructions received and completing the registration process online at the Website, as well as pass authentication tests requiring the requesting of a one-time password (OTP) via text and entering the OTP on the registration form; and (ii) thereafter upload a photograph (png, jpeg, pdf, and tiff file types with a maximum file size of 10MB) of the applicable sales receipt of the Qualifying Purchase in its entirety (such photograph, a "**Receipt Image**") identifying the applicable Participating Retailer, the Participating Product and date of purchase. Entrants are strongly encouraged to remove, obscure or redact out any personal information that appears on the Receipt Image. For each eligible Participating Product in the applicable Receipt Image, you will receive one (1) Entry into the Sweepstakes **subject to a maximum of five (5) Entries** per eligible Receipt Image regardless of number of Participating Products purchased on the Receipt Image, subject to a maximum of forty (40) Entries per person for the duration of the Sweepstakes regardless of the method of Entry. Limit one (1) Receipt Image per day subject to a maximum.

ENTRANTS ARE REQUIRED TO KEEP ORIGINAL SALES RECEIPT. Sponsor reserves the right to request from a person the original sales receipt used for the purposes of this Sweepstakes for further verification purposes at any time and for any reason. Standard data charges may apply to Entrants who choose to enter the Sweepstakes via a mobile device. Please contact your service provider for rates and service plan information prior to participating with your mobile device.

Once your valid eligible No Purchase Submission has been received in accordance with these Rules, you will automatically receive five (5) Entries for each complete envelope submitted. Limit eight (8) envelopes per person. In order to be valid and eligible, the No Purchase Submission must: (i) be received individually in an envelope with sufficient U.S. postage; (ii) be postmarked by September 1, 2025, and received by September 5, 2025; and (iii) contain all of the information listed above. The Sponsor takes no responsibility for any lost, stolen, delayed, illegible, damaged, misdirected, late or destroyed No Purchase Submissions.

Maximum of **forty (40) Entries** per person for the duration of the Sweepstakes regardless of the method of Entry.

General Entry Official Rules.

All Entries submitted in compliance with these Official Rules and not disqualified or void are considered "**Eligible Entries.**" All Entries are the property of Sponsor.

Standard data charges may apply to Participants who choose to enter the Sweepstakes via a mobile device. Please contact your service provider for rates and service plan information prior to participating with your mobile device.

By entering this Sweepstakes, each Entrant: (i) agrees to release, indemnify, discharge, defend and hold harmless the Sponsor, the Sweepstakes Entities, and each of their respective officers, directors, employees, agents, representatives and assigns (collectively, the "**Released Parties**") from any claim or liability arising from or related to the Entry or participation in this Sweepstakes, (ii) grants Sponsor a non-exclusive, unlimited, royalty free, irrevocable, right and license to use, publish, display, produce, perform, convert, adapt, publicly present, communicate to the public, assign, sub-license, edit, modify, translate, reproduce, dispose of, post, broadcast or otherwise use the Entry, in whole or in part, in any way and in any form of media now known or hereafter developed, including, without limitation, as contemplated within these Rules, or in any advertising or promotions created by Sponsor in any form of media to promote this Sweepstakes and/or future Sweepstakes similar to this Sweepstakes, without review, notice, approval or compensation; (iii) waives all moral rights in and to the Entry in favor of Sponsor; and (iv) represents, warrants to Sponsor that he/she has the authority to grant to Sponsors the rights granted in these Rules, including without limitation the non-exclusive license, above.

Entries become the property of Sponsor and will not be returned. Released Entities are not responsible for lost, late,

illegible, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind, whether mechanical, human or electronic. Released Parties shall not be responsible for incorrect or inaccurate entry information whether caused by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error which may occur in sending an email or the processing of the Entries in the Sweepstakes. Released Parties assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of Entries. Only fully completed entries are eligible. Released Parties are not responsible for any change of email address, mailing address and/or telephone number of Entrants. In the event of a dispute regarding the identity of the person submitting an Entry, the Entry will be deemed submitted by the person in whose name the email account is registered, provided that person meets all eligibility criteria set forth in these Rules.

- 5. LIMIT ON THE NUMBER OF ENTRIES:** The number is limited to forty (40) Entries per Entrant during the entire Sweepstakes Period, regardless of method of Entry. For greater certainty and for the avoidance of doubt, you may only use one (1) email address to enter the Sweepstakes, and multiple Entrants are prohibited from sharing the same email account. If the Sponsor discovers (based on any evidence or information made available to or otherwise discovered by the Sponsor) that an individual: (i) has attempted to obtain more than forty (40) Entries (regardless of method of entry); and/or (ii) has attempted to use multiple names, identities, email addresses, or any automated, macro, script, robotic, or other system or program and/or any other means that is not in accordance with Sponsor's interpretation of the letter and spirit of these Rules to enter or otherwise participate in this Sweepstakes, or to disrupt the conduct of the Sweepstakes; such person may be disqualified from the Sweepstakes at the sole and absolute discretion of the Sponsor. For the No Purchase Submission Entries, the Sponsor will accept only one (1) letter, per envelope, per Entrant.

- 6. PROCESSING OF RECEIPT IMAGES:** Processing of a Receipt Image may take two (2) business days from the time the Receipt Image is received by the Administrator. Once an Entrant's Receipt Image is processed, such Entrant will be notified via email only if such Receipt Image has been invalidated with a reason why such Receipt Image could not be processed at such time, as determined by the Administrator in its sole and absolute discretion. It is the responsibility of the Entrant to check the applicable email account/phone for such notification including in the inbox, spam or junk folders. The Sweepstakes Entities do not assume any responsibility and are not responsible for electronic communications which are undeliverable for any reason, including (but not limited to) as a result of any form of active or passive filtering of any kind or insufficient space in a participant's mailbox or telephone to receive e-mail messages, or other communications. All Receipt Images become the property of Released Parties and will not be returned. Sweepstakes is void where taxed, prohibited, or restricted by law. Receipts obtained through unauthorized means or illegitimate channels (i.e., other than via purchase of Participating Products from a Participating Retailer) will be void. Receipts that cannot be validated for any reason will be rejected, as determined by the Sponsor in its sole discretion. For example only, and not an all-inclusive list, a receipt will be rejected if it: (i) fails to pass anti-fraud detection measures; (ii) is unauthorized, fake, or has been illegitimately obtained; (iii) contains any messages, code or other markings not recognized by the Sweepstakes Parties; (iv) contains printing or other errors; (v) is illegible, unreadable or blank; (vi) has been previously used; (vii) reflects the use of more than an authorized number of coupons; or (viii) is incorrectly or incompletely entered or submitted.

- 7. VERIFICATION:** All Entries may be subject to verification at any time and for any reason. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identification and/or eligibility (in a form acceptable to the Sponsor, including, but not limited to, government-issued photo identification): (i) to verify an individual's eligibility to participate in this Sweepstakes; (ii) to verify the eligibility and/or legitimacy of any Entry, submission and/or information submitted (or purportedly submitted) for the purposes of this Sweepstakes; and/or (iii) for any other purpose that Sponsor deems necessary, in its sole and absolute discretion, for the administration of this Sweepstakes in accordance with Sponsor's interpretation of the letter and spirit of these Rules. Any Entrant who fails to provide such proof to the complete satisfaction of the Sponsor, within the time period specified by the Sponsor, may be disqualified in the sole and absolute discretion of the Sponsor. Only the official timekeeping device(s) of the Sponsor will determine the time for the purposes of this Sweepstakes.

Disqualification. Entrants must comply with the following conditions, or they may be disqualified, and their Entry may be cancelled:

- Entrants must use a valid email address.
- Entrants cannot share the same email address.
- Only forty (40) Entries or submissions per Entrant will be permitted for the Entire Sweepstakes Period, regardless of method of Entry.
- Entrants must use the same email address at all times during the Sweepstakes Period.
- Use of more than one (1) email address will result in automatic disqualification.
- Multiple accounts created by the same Entrant will be disqualified.

8. PRIZES/APPROXIMATE RETAIL VALUES ("ARV")/ODDS:

One (1) Grand Prize ("**Grand Prize**", or "**Prize**") of an Ultimate Gaming Package comprising solely of: (i) Four (4) Custom PCs ARV \$20,000 (\$5,000 each); (ii) Four (4) AGON Pro monitors ARV \$5,600 (\$1,400 each); (iii) Four (4) Secret Lab Gaming Chairs ARV \$2,200 (\$550 each); (iv) Four (4) Elgato Neo Bundles (Key Light Neo, Stream Deck Neo, Wave Neo, Game Capture Card Neo) ARV \$1,600 (\$400 each); (v) Four (4) Scuf controllers ARV \$720 (\$180 each); (vi) Four (4) Gaming headsets ARV \$600 (\$150 each); (vii) Four (4) Corsair MMO Gaming Bundles- K55 Pro Keyboard and Scimitar Pro Mouse ARV \$400 (\$100 each). The TOTAL ARV of the Grand Prize is thirty-one thousand, one hundred and twenty dollars (\$31,120).

Prize must be accepted as is and is not transferable, assignable or redeemable for cash (except as expressly permitted by the Sponsor in its sole and absolute discretion). No substitutions are permitted, except at the discretion of the Sponsor. The Sponsor reserves the right, in its sole and absolute discretion, to substitute a Prize or Prizes with a prize of equal or greater value, including, but not limited to, in the sole and absolute discretion of the Sponsor, a cash prize. Any prize depicted in promotional materials is for illustration purposes only and may not be the exact item(s) offered as a prize.

Sponsor will also provide the winner of the Grand Prize a single cash payment in the form of a check "" which is intended to assist the winner with any federal, state or other liability associated with the Grand Prize ("**Tax Gross-Up Payment**"). The Tax Gross-Up Payment will be determined in the Sponsor's sole discretion. The Tax Gross-Up Payment may not cover the entirety of the winner's tax liability, and the Grand Prize winner is solely responsible for all applicable federal, state or other tax obligations related to the Grand Prize. The Sponsor will not provide any further assistance towards the winner's tax obligations. The Sponsor will report the fair market value of the prize and the Tax Gross-Up Payment to the IRS and issue an IRS Form 1099-MISC or other applicable forms. The winner should consult their tax advisor regarding the proper reporting and payment of any taxes associated with the prize.

Odds of winning the Grand Prize depend on the number of eligible entries received in accordance with these Rules during the Sweepstakes Period.

The Grand Prize will be delivered to the physical mailing address of the confirmed winner(s) four to six (4-6) weeks after being confirmed as an eligible winner.

In no event will the Sponsor be responsible for more than one (1) Prize. If computer, printing, production, mechanical, seeding, typographical or other errors result in more valid prize claims than the number of available prizes stated herein, the Sponsor reserves the right to award the number of prizes stated herein by random drawing from among all eligible, non-suspect, valid prize claims received for the prize in question.

None of the Released Parties makes any representation or warranties, express or implied, as to the quality or suitability of any Prize awarded in connection with the Sweepstakes. To the fullest extent permitted by law, each selected Entrant understands and agrees that they will not seek reimbursement or any legal or equitable remedy against Sponsor and the Released Parties, whoever they may be, in the event that the Prize awarded to them is unsatisfactory for any reason or is unsuitable for their particular purpose.

- 9. WINNER SELECTION AND NOTIFICATION:** On September 8, 2025, at 2:00 PM (ET), a total of one (1) potential prize winner will be selected by random draw from all valid Entries received during the Sweepstakes Period. The draw will be conducted at the Administrator's offices in Detroit, Michigan (U.S.). Potential prize winners will be notified by email, phone and/or mail, using contact information provided or collected at the time of entry. If a potential winner is considered a minor in their state or jurisdiction of residence, the prize will be awarded in the name of their parent or legal guardian, who must comply with all the requirements set forth in these Official Rules. The parent or legal guardian may be required to execute all necessary documentation on behalf of the minor winner, including but not limited to an Affidavit of Eligibility, Liability Release, and, where legally permissible, a Publicity Release. Sponsor shall have no liability for any winner notification that is lost, intercepted, or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within five (5) calendar days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected, time permitting. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners of a prize in accordance with the above procedure, after which the prize in may go unawarded if it remains unclaimed.

NO POTENTIAL WINNER IS A WINNER UNTIL THE SPONSOR HAS OFFICIALLY DECLARED THAT THE POTENTIAL WINNER A WINNER IN ACCORDANCE WITH THESE RULES.

Official Time. The Sweepstakes Administrator's servers are the official tool for determining the time for this Sweepstakes. The time an Entry is received by the Sweepstakes Administrator will be deemed to be the time it is received by the Sweepstakes Administrator's mail or web server (whichever is applicable) as determined by the clock on that server.

Winners acknowledge that upon acceptance of a Prize, performance of Prize obligations becomes the sole and exclusive responsibility of the designated service provider(s) for those portions not originating with Sponsor, if any.

10. GENERAL: All federal, provincial/territorial, and local laws and regulations apply. Released Parties will have no liability whatsoever for any injuries, losses or damages of any kind caused by any prize or resulting from acceptance, possession, use and/or misuse of any prize or participation in the Sweepstakes or any prize-related activities. By participating and accepting the prize, winner agrees to hold harmless Released Parties and each of their respective affiliates, directors, employees, officers and agents from any and all liability, injury, loss or damage of any kind, including but not limited to personal injury or death, arising from or in connection with participation in the Sweepstakes, or the awarding, receipt, possession, use or misuse of any prize and/or prize related activity. Sponsor is not responsible for any typographical or other error in the printing of the offer or in the administration of the Sweepstakes.

Unless otherwise prohibited from doing so by applicable law, the Entrant agrees to the following releases:

Released Parties are not responsible for lost, late, mutilated or illegible entries nor for electronic transmission errors resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions or limitations of any kind, or inaccurate transmissions of or failure to receive entry information by Sponsor on account of technical problems or traffic congestion on the Internet or at any website and/or wireless network or any combination thereof.

Sponsor, reserves the right to modify, extend, suspend, or terminate the Sweepstakes if it determines, in its sole discretion, that the Sweepstakes is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond Sponsor's control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper entry and/or feasibility of the Sweepstakes as contemplated herein. If for any reason the online Sweepstakes is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Sponsor which corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Sweepstakes, the Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify

or suspend the Sweepstakes. In such event, Sponsor shall post notice on the Website as soon as practical after any action is taken and award the prizes from among all eligible non-suspect entries received up to the action taken by the Sponsor provided a sufficient number of eligible entries have been received. The invalidity or unenforceability of any provision of these Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
