

## GARAGE BEER KELCE CADDY SWEEPSTAKES

### Official Rules

The Garage Beer Kelce Caddy Sweepstakes ("Sweepstakes") is sponsored by Jock Beer, LLC dba Garage Beer (the "Sponsor"). The Sponsor's address is 1610 Oak St, Columbus, OH 43205. The Sweepstakes begins at 12:00 a.m. Eastern Time ("ET") on March 1, 2025, and ends at 11:59 p.m. ET on May 31, 2025 ("Sweepstakes Period"). The computer clock of Sponsor is the official time-keeping device in Sweepstakes, and the Sponsor may also rely on the time processing functions of third parties. Sponsor shall have the sole discretion in determining the timeliness of any action or inaction related to this Sweepstakes.

- 1. ELIGIBILITY:** The Sweepstakes is open only to individuals who: (a) are legal residents of the fifty (50) United States and the District of Columbia (the "Eligibility Area"); (b) 21 years of age or older at the time of entering the Sweepstakes; and (c) submit a valid Entry (as defined below) (each such individual, an "Entrant" or "you"). This Sweepstakes is **not open** to Entrants who: (i) are employees, officers, directors, agents and representatives of the Sponsor or any entity which is involved in any aspect of the creation, production, operation, execution or fulfillment of the Sweepstakes, (such entities, collectively, the "Sweepstakes Entities"), or any alcohol beverage licensees (including alcohol beverage suppliers, wholesalers, distributors or retailers); (ii) are immediate families (defined as parents, child, sibling, domestic partner, spouse and their respective spouses, regardless of where they reside) or household members (defined as those people who share the same residence at least three (3) months a year) of such individuals listed in clause (i) above); (iii) are prohibited by applicable law from entering the Sweepstakes; or (iv) do not meet any of the eligibility requirements set forth above.

form (the "Registration Form"). Required fields of the Registration Form include Full Name, Date of Birth, Complete Mailing Address including Zip Code, Email Address (which has to be the same primary Email Address associated with the Account), Phone Number & Opt-in to the Official Rules & Privacy Policy for the Sweepstakes, as well as pass authentication tests requiring the requesting of a one-time password (OTP) via text and entering the OTP on the registration form. See instructions below on how to access the Sweepstakes Site. Each such completed and validly submitted Registration Form, an "Entry". Entry is not valid without each step.

Sponsor may, in its sole discretion, accept or reject any purported Entry that does not comply with these Official rules. Purported Entries that are incorrect or incomplete, received outside the Sweepstakes Period (including after all Prize(s) have been redeemed), or that contain obscene, offensive, or any other language communicating messages inconsistent with the positive images with which Sponsor wishes to associate itself (all as determined by Sponsor in its sole discretion) will be void and disqualified.

- b. Upon confirmation of your age, you will be directed to the Registration Form where you must completely enter your true and correct information in the required fields as well as pass specified authentication tests, and thereafter submit the Registration Form.

Proof of scanning QR codes does not constitute proof of completion or submission of an Entry. To scan a QR code, participants must have a smart phone or other web-enabled device with a camera feature and QR scanner application and may incur message or data charges from their wireless service provider for each message sent and received. If you do not have a QR reader already installed on your phone, type "QR reader" in your mobile device's application store search field to find available QR readers for your smart phone or other web-enabled device. You will receive a response which will contain a link to download a QR reader for your specific device. Check with your wireless service provider for details on these and other applicable charges. Participants are solely responsible for any such wireless charges. Not all wireless carriers participate

- B. Mail-In Entry/ Entry Without Purchase: To obtain an entry by mail, Entrants must hand print their first and last name, residence address, telephone number, email address, and date of birth on a 3"x5" card, place the card in an envelope with proper first-class postage affixed, and mail the envelope to "Garage Beer Kelce Caddie Sweepstakes" c/o Snipp Interactive, 6320 NW 97 Avenue, Doral, FL 33178. Mailed entries must be postmarked up to one (1) business day after the end date of the Sweepstakes Period and received within four (4) business days following the respective post mark date. There is a limit of one (1) 3"x5" card per mailing envelope. A mailed entry submitted in accordance with these Official Rules will result in the Entrant obtaining one (1) entry into the Sweepstakes.

**Limit of one (1) Prize per person, per email address and per household.**

The potential winners may be required to show proof of being the Authorized Account Holder.

- 3. WINNER SELECTION; DRAWING:** On or about June 6, 2025 (the "Drawing Date"), Sponsor will randomly select one (1) potential grand prize winner and ten (10) potential secondary prize winners from among all eligible Entries who submit a valid Entry during the Sweepstakes Period. ("Drawing").

Odds of winning the Grand Prize (defined below) or Secondary Prize (defined below) depend on the number of eligible Entries received during the Sweepstakes Period.

- 4. WINNER NOTIFICATION AND CONFIRMATION:** The potential Grand Prize winner will receive notification via phone call and Secondary Prize winners will receive a prize notification via email and/or phone call as soon as reasonably practicable after the winner selection, via the contact information provided in their Registration Form where they may be asked to confirm their intention to be potentially awarded the Prize. - The Grand Prize for Winner and one guest (the "Guest") is as follows: two tickets to the American Century Championship Celebrity Golf Tournament (July 9, 2025 to July 13, 2025) (approximate value \$300.00) (the "ACC Tournament"); four night/five day stay at hotel near the ACC Tournament (approximate value \$1500); two plane tickets comprising solely of round trip, coach air transportation for Winner and Guest between a major gateway airport near Winner's home and airport closest to the ACC Tournament in Lake Tahoe, Nevada (approximate value \$1200.00); a Garage Beer x Kelce Swag pack (approximate value \$50.00); meal stipend for two people for four days (\$600 value) in the form of a check; and if time and/or circumstances allow, Winner and Guest may be able to meet Jason Kelce and/or Travis Kelce. Approximate Retail Value ("ARV") of Grand Prize is \$3650.00. In the event the ACC Tournament is canceled, and/or in the event Jason Kelce and/or Travis Kelce are unavailable to meet the Winner and Guest for any reason whatsoever, the Winner will be paid the remaining value of the total Prize value received up to that time."
- Each of the 10 Secondary Prizes is comprised of one (1) Swag Putter (each, ARV \$100).

**No alcohol will be awarded as part of any Prize.**

**The Total ARV of all Prizes is thirty-two thousand dollars (\$4,650.00).** The ARV is subject to change based upon current market conditions at the time of Prize fulfillment. Any difference between the ARV and the actual value, if any, will not be awarded. **Limit one (1) Prize per person.** All Prize details not specified in these Official Rules will be determined at the Sponsor's sole discretion. If for any reason a Prize is unavailable, Sponsor reserves the right to modify the Sweepstakes in its sole discretion and award a substitute prize, or portion of a prize, of comparable or greater value as set forth in these Official Rules.
