

**Gerber Off to Daycare  
Offer Terms and Sweepstakes Official Rules**

The Gerber Off to Daycare Promotion (“Promotion”) consists of a Sweepstakes (“Sweepstakes”) and an offer (“Offer”).

**Eligibility:** The Promotion is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years of age (or 19 if a resident of AL or NE, 21 and older for residents of MS) at the time of participation. Employees, officers and representatives and members of the immediate families (i.e., parents, spouses, siblings, children, grandparents, step parents, step children and step siblings, and their respective spouses, and those living in the same household, whether or not related) of Sponsor, Administrator, Nestlé USA, Inc. and their respective affiliated companies, parent companies, subsidiaries, participating promotional partners, retailers, distributors, advertising and promotion agencies, webmasters and any company involved in the creation, design, execution, production, or fulfillment of the Promotion (collectively, the “Promotion Entities”) are not eligible. The Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation in the Promotion constitutes participant’s full and unconditional agreement to these Offer Terms and Official Rules and Sponsor’s and Administrator’s decisions, which are final and binding in all matters related to the Promotion. Receiving a Reward (defined below) and winning a prize is contingent upon fulfilling all requirements set forth herein.

**Timing:** The Promotion begins on August 13, 2023 at 12:00:01 a.m. Eastern Time (“ET”) and ends on September 17, 2023 at 11:59:59 p.m. ET (the “Promotion Period”).

The Offer consists of two (2) phases (each a “Phase”) as set forth below.

Administrator's computer is the official time-keeping device for the Promotion.

**How to enter the Sweepstakes without making a purchase (e.g., participating in the Offer):** To obtain an entry by mail and without purchase, entrants must hand print their first and last name, address, telephone number, email address, and date of birth on a 3"x5" card, place the card in an envelope with proper first-class postage affixed, and mail the envelope to "Gerber Off to Daycare Sweepstakes" c/o Snipp Interactive, PO Box 2749, Carlsbad, California 92018, to be postmarked by September 18, 2023 and received by September 22, 2023. Limit one (1) Sweepstakes entry per stamped, outer envelope. Mechanical reproduction and stamped entries will not be accepted. For the avoidance of doubt, entering the Sweepstakes via this method does not qualify for the \$5 reward. To be eligible for the reward, participants must participate in the Offer and make a Qualifying Purchase (as defined below).

**How to participate in the Offer and receive a Sweepstakes Entry by making a purchase:** During Phase 1, purchase qualifying Gerber products (minimum purchase spend of \$15) in a single transaction (on a single receipt), at any retail store location or online (each a "Qualifying Purchase"). For a list of participating products (the "Qualifying Products"), see **Exhibit A** below. Net purchase determined after all discounts, offers and coupons. Be sure to keep your receipt. Then take a photo of your entire receipt ("Receipt Image"). Receipt Image must be clear and legible and include the purchase date and timestamp of your receipt, show the Qualifying Purchase(s), including the price of the Qualifying Product(s) as well as the total amount of money spent (note: Participants are encouraged to blank out any personal information that appears on the sales receipt).

Then, during Phase 2, visit [www.GerberDayCareSweeps.com](http://www.GerberDayCareSweeps.com) ("Website"), click/tap on the "Get Started" button and where prompted, follow the instructions to upload a Receipt Image to receive one (1) five-dollar (\$5) digital reward (while supplies last) ("Reward") and one (1) Sweepstakes entry.

Upon emailing a Receipt Image, participants will be sent a link to a registration/entry form for the Reward and Sweepstakes entry; allow approximately 30 minutes to receive the link\*\*. Then read and accept any required terms and conditions, complete and submit the registration/entry form to receive one (1) Reward and one (1) Sweepstakes entry. Each receipt/Receipt Image may only be used once. Multiple participants are not permitted to share the same email address. **Processing of Receipt Images:** Processing of a Receipt Image will take 48 hours from the time the Receipt Image is received by the Administrator. Once a Participant's Receipt Image is processed, such Participant will be notified via email, whether such Receipt Image has been successfully validated or a reason why such Receipt Image could not be processed. It is the responsibility of the Participant to check the applicable email account for such notification including in the inbox, spam or junk folders. **Verification:** Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor for the purposes of verifying an individual's eligibility to participate in this Promotion; for legitimacy of any Receipt Image (which may include providing the original receipt); or for any other reason. Failure to provide such proof to the complete satisfaction of the Sponsor within the timeline specified by the Sponsor or its Administrator, may result in disqualification. Proof of transmission (screenshots or captures etc.), or attempted transmission does not constitute proof of delivery.

**Redemption Requests/Distribution of Rewards:** Participants who are eligible, will receive their Reward (at the email address provided during registration) in approximately 48 hours. **Drawing/Winner Notification:** On or about September 25, 2023, Administrator will randomly select one potential (1) grand prize winner ("Grand Prize Winner") and five (5) potential first prize winners ("First Prize Winners") from among all eligible Entries received during the Promotion Period. Odds of winning depend on the total number of eligible Entries received during the Promotion Period.

Grand Prize Winner and First Prize Winners are considered "potential" winners pending verification of their eligibility and compliance with these Official Rules. Administrator will make two (2) attempts within a twenty-four (24) hour period to notify the potential Grand Prize Winner and the potential First Prize Winners at the email address or phone number submitted at the time of Entry. Potential Grand Prize Winner and potential First Prize Winners must respond within forty-eight (48) hours of notification. Failure

of potential Grand Prize Winner or a potential First Prize Winner to respond within forty-eight (48) hours of notification may result in disqualification and an alternate potential Grand Prize Winner or potential First Prize Winners may be selected, as applicable. Potential Grand Prize Winner will be required to sign a winner's agreement and release ("Winner Release") and return it by the date specified in Administrator's notification, or Grand Prize will be forfeited in its entirety and another potential Grand Prize Winner may be selected. The potential Grand Prize Winner will also be required to execute and return an IRS Form W-9 (and will receive a subsequent 1099 IRS Form for the actual retail value of Grand Prize) along with a Winner Release and any other documentation that Sponsor and Administrator may require and return it by the date specified by Sponsor or Administrator in the notification, or Grand Prize may be forfeited in its entirety and another potential Grand Prize Winner may be selected. If a potential Grand or First Prize Winner is found not to be eligible or not in compliance with these Official Rules, or if prize notification or prize is returned as undeliverable, such potential Grand or First Prize Winner may be disqualified and an alternate winner will be selected for the prize at issue. Sponsor and Administrator are not responsible for any change of email address or phone number of any entrant. **General Conditions:** Sponsor reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, for any reason whatsoever, including, without limitation, fire, flood, natural or man-made epidemic of health of other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis, order of any court or jurisdiction or if any fraud, technical failures or any other factor impairs the integrity or proper functioning of the Promotion, as determined by Sponsor in its sole discretion. If the Promotion is terminated before the end date and time, Sponsor may (if possible), in its sole and absolute discretion, randomly select potential winners for the Sweepstakes from among all eligible, non-suspect Entries received as of the date and time of the event giving rise to the termination or as otherwise deemed fair and appropriate by Sponsor; if terminated, with respect to the Offer, Sponsor will redeem any valid, non-suspect redemption requests received up to time of such action, while supplies of Rewards last. Any dispute or portion thereof, or any claim for a particular form of relief (not otherwise precluded by any other provision of these Official Rules), that may not be arbitrated pursuant to applicable state or federal law may be heard only in a court of competent jurisdiction in Arlington County, VA; (iii) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental, and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
