

Hornitos® Día de los Muertos 2026 Sweepstakes

Official Rules:

The Hornitos® Día de los Muertos 2026 Sweepstakes ("Sweepstakes") is sponsored by Jim Beam Brands Co. (the "Sponsor"). The Sponsor's address is Merchandise Mart, 222 W. Merchandise Mart Plaza, Suite 1600, Chicago, IL 60654.

The Sweepstakes begins at 12:00:01 a.m. Eastern Time ("ET") on September 15, 2026, and ends at 11:59:59 p.m. ET on November 2, 2026 ("Sweepstakes Period"). The computer clock of Sponsor is the official time-keeping device in the Sweepstakes, and the Sponsor may also rely on the time processing functions of third parties. Sponsor shall have the sole discretion in determining the timeliness of any action or inaction related to this Sweepstakes.

- 1. ELIGIBILITY:** The Sweepstakes is open only to individuals who: (a) are legal residents of the fifty (50) United States and the District of Columbia (the "Eligibility Area"); (b) are 21 years of age or older at the time of entering the Sweepstakes; (c) agree to be bound by the terms of these Official Rules; and (d) submit a valid Entry (as defined below) (each such individual, an "Entrant" or "you"). This Sweepstakes is **not open** to Entrants who: (i) are employees, officers, directors, agents and representatives of the Sponsor, Snipp Interactive Inc. Limit of one (1) Entry per person, per email address, throughout the Sweepstakes Period, regardless of method of Entry.

3. **WINNER SELECTION; DRAWING:** There is one (1) Grand Prize drawing ("Grand Prize Drawing") which will take place on or about November 4, 2026, from among all eligible entries received during the Sweepstakes Period. Odds of winning will be determined by the total number of eligible entries received during the Sweepstakes Period. **EACH ENTRANT IS ELIGIBLE TO WIN ONLY ONE (1) PRIZE DURING THE SWEEPSTAKES PERIOD.**
4. **WINNER NOTIFICATION AND CONFIRMATION:** The potential prize winners will receive a prize notification via email and/or phone call as soon as reasonably practicable after the winner selection, via the contact information provided in their Registration Form where they may be asked to confirm their intention to be potentially awarded the prize. The potential prize winner(s) will also be sent a Declaration of Eligibility and Liability/Publicity Release for such winner and a Guest Liability/Publicity Release for their Guest (collectively, the "Winner Documentation") via email, which must be duly completed, signed, and returned to Administrator within five(5) days of date of issuance. 5. **PRIZE; PRIZE TERMS:** The Grand Prize Drawing will award one (1) grand prize (the "Grand Prize" or "Prize") comprising a 4-day/3-night trip for the winner and one (1) guest (the "Guest") to Mexico City (the "Trip") for the Día de los Muertos celebration, comprising solely of: (i) round-trip economy class airfare for two (2) from a major U.S. gateway airport to Mexico City and 3 nights/4 days accommodations (one (1) standard room, double occupancy) at a 4-star hotel of Sponsor's sole

choosing at the destination ; (ii) onsite airport transfers for two (2) at the destination city ; and (iii) parade watching experience for two (2). **No alcohol will be awarded as part of the Prize.**

The ARV of the Grand Prize is \$5,480. The ARV is subject to change based upon current market conditions at the time of Prize fulfillment. Any difference between the ARV and the actual value, if any, will not be awarded. Limit one (1) prize per winner. All Prize details not specified in these Official Rules will be determined at the Sponsor's sole discretion.
