## Hot Pockets and Magic the Gathering: Arena 30 Years Sweepstakes Official Rules

**Sweepstakes Period:** The Sweepstakes begins at 12:00:01 A.M. Eastern Time ("ET") on June 1, 2023 and ends at 11:59:59 P.M. ET on June 14, 2023 ("Sweepstakes Period").

**Eligibility:** The Hot Pockets and Magic the Gathering: Arena 30 Years Sweepstakes ("Sweepstakes") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years of age (or 19 if a resident of AL or NE, 21 and older for residents of MS) at the time of entry. ONLY PHOTOS THAT INCLUDE ONE (1) OF EACH OF THE FIVE (5) SPECIALLY-MARKED HOT POCKETS OUALIFYING PRODUCTS ARE VALID FOR ENTRY — ONE (1) BLUE BOX, ONE (1) RED BOX, ONE (1) GREEN BOX, ONE (1) WHITE BOX and ONE (1) BLACK BOX. ALL FIVE (5) BOXES MUST BE INCLUDED IN THE PHOTO. Blurry and/or unreadable images will be rejected. A list of qualifying products is set out in Exhibit "A" (each, a "Qualifying Product").

**Free Mail Method of Entry**: To obtain an entry without a photo and without making a purchase, legibly handprint your name, complete home address (street, city, state and ZIP code; (P.O. Boxes are not permitted)), telephone number, complete email address and "Hot Pockets and Magic the Gathering: Arena 30 Years Sweepstakes Entry" on a 3" x 5" card/paper and mail it in a first-class stamped envelope to: Hot Pockets and Magic the Gathering: Arena 30 Years Sweepstakes, c/o Snipp Interactive, P.O. **Grand Prize:** \$12,500 awarded in the form of a check made payable to Grand Prize Winner (as defined below). Approximate Retail Value ("ARV") of Grand Prize is \$12,500.

**Drawing/Winner Notification:** On or about June 22, 2023, Administrator will randomly select one potential (1) grand prize winner ("Grand Prize Winner") from among all eligible Entries received during the Sweepstakes Period. Odds of winning the Grand Prize depend on the total number of eligible Entries received during the Sweepstakes Period.

Grand Prize Winner is considered a "potential" winner pending verification of his/her eligibility and compliance with these Official Rules. Administrator will make two (2) attempts within a twenty-four (24) hour period to notify potential Grand Prize Winner at the email address or phone number submitted at the time of his/her Entry. Potential Grand Prize Winner must respond within forty-eight (48) hours of notification. Failure of potential Grand Prize Winner to respond within forty-eight (48) hours of notification may result in disqualification and an alternate potential Grand Prize Winner will be selected. Potential Grand Prize Winner will be required to sign a winner's agreement and release ("Winner Release") and return it by the date specified in Administrator's notification, or Grand Prize will be forfeited in its entirety and another potential Grand Prize Winner may be selected. The potential Grand Prize Winner will also be required to execute and return an IRS Form W-9 (and will receive a subsequent 1099 IRS Form for the actual retail value of Grand Prize) along with a Winner Release and any other documentation that Sponsor and Administrator may require and return it by the date specified by Sponsor or Administrator in the notification, or Grand Prize may be forfeited in its entirety and another potential Grand Prize Winner may be selected. Either party may enforce a final arbitration award in any court of competent jurisdiction in Arlington County, VA including an award of costs, fees and expenses incurred in enforcing the award. Sweepstakes Entities shall be entitled to seek injunctive relief (unless otherwise precluded by any other provision of these Official Rules) in the state and federal courts of Arlington County, VA. Any dispute or portion thereof, or any claim for a particular form of relief (not otherwise precluded by any other provision of these Official Rules), that may not be arbitrated pursuant to applicable state or federal law may be heard only in a court of competent jurisdiction in Arlington County, VA; (iii) any and all claims, judgments, and awards shall be limited to actual out-of- pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental, and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
