The Program is subject to these official rules and terms and conditions (the “Official Rules”), and by participating and/or entering, the participant (the “Participant” or “you”) and/or entrant (“Entrant” or “you”) agrees to be bound by them and the decisions of Sponsor, which are final and binding in all respects. This Program begins at 12:00:01 AM Central Time (CT) on August 01, 2024, and ends at 11:59:59 PM CT on September 15, 2024 (the “Program Period”). Administrator’s computer is the official timekeeping device for participation in the Program.

1. Eligibility:

The Program is open to persons who are legal residents of, and physically located in the fifty (50) United States and the District of Columbia (the “Eligibility Area”), who are at least eighteen (18) years of age at the time of submission (“Eligible Participants”, “Eligible Entrants” or “you”). VOID OUTSIDE THE ELIGIBILITY AREA OR WHERE PROHIBITED OR RESTRICTED BY LAW OR THESE OFFICIAL RULES. Employees, officers and representatives and members of the immediate families (*i.e.*, parents, spouses, siblings, children, grandparents, step parents, step children and step siblings, and their respective spouses, and those living in the same household, whether or not related) of Sponsor, Snipp Interactive Inc. (the “Administrator”), the PDL Entities, Fanatics Retail Group Fulfillment, LLC (“Fanatics”), and their respective affiliated companies, parent companies, subsidiaries, participating promotional partners, retailers, distributors, advertising and promotion agencies, webmasters and any company involved in the creation, design, execution, production, or fulfillment of the Program (the “Program Entities”) are not eligible to participate in the Program. “PDL Entities” means MLB Professional Developments Leagues, LLC (“PDL”), each PDL Club, each of their subsidiaries or affiliated entities, any entity which now or in the future controls, is controlled by, or is under common control with PDL and the PDL Clubs, and all officers, directors, employees, agents, partners, and members of those entities. “MLB Entities” means the Office of the Commissioner of Baseball (“BOC”), its Bureaus, Committees, Subcommittees and Councils, the Major League Baseball Clubs (“Clubs”), MLB Advanced Media, L.P., Major League Baseball Properties, Inc., The MLB Network, LLC, each of their parent, subsidiary, affiliated, and related entities, any entity which, now or in the future, controls, is controlled by or is under common control with the Clubs or the BOC, and the owners, general and limited partners, shareholders, directors, officers, employees, and agents of the foregoing entities.

2. The Program:

Eligible Participants who purchase three (3) or more Participating Products A OR one (1) or more Participating Products B as set out in Exhibit A attached hereto and incorporated herein by reference (each a "Participating Product") during the Purchase Period (defined below) from any participating retailer or online in the Eligibility Area (each, a "Participating Retailer") in a single transaction (such purchase, a "Qualifying Purchase"), are given the opportunity to each receive: (A) one (1) Entry (defined below) into the "C4 Performance Energy® x MiLB Triple-A" Sweepstakes (such sweepstakes, the "Sweepstakes"); and (B) one (1) twenty dollar (\$20) Fanatics code (such code, a "Reward", and such Reward offer, the "Promotion"), while supplies of Rewards last. Complete the registration form by entering true and accurate information in the required fields (including, First Name, Last Name, Street Address, City, State/Province, Zip Code, E-Mail Address, and phone number). Follow instructions and submit Receipt Image (including reading and accepting any required terms and conditions) to register for the Promotion.

Registering for the Promotion is the only way to receive a Reward, which will be sent to the email address provided during registration, approximately 48 hours after you have been found eligible to receive a Reward, only while Rewards last. Without the information supplied via registration, we cannot send you your Reward.

Limit two (2) Fanatics code per person during the Program Period.

3.2 Distribution of Rewards:

Participants who register a valid Submission will receive their Reward sent to the email address provided during registration, approximately 48 hours after such Participant has been found eligible to receive a Reward, only while Rewards last.

All Entries submitted in compliance with these Official Rules and not disqualified or void are considered "Eligible Entries." All Entries are the property of Sponsor.

Standard data charges may apply to Participants who choose to enter the Program via a mobile device. Please contact your service provider for rates and service plan information prior to participating with your mobile device.

Program Entities shall not be responsible for lost, late, stolen, damaged, garbled, inaccurate, incomplete, misaddressed, mutilated, undelivered, delayed, or misdirected emails, requests, Entries, and/or Prize claims, or for errors, omissions, interruptions, deletions, defects, or delay in cable, satellite, internet service provider, telephone lines, or in operations or transmission of information, in each case whether arising by the way of technical or other failures or malfunctions of computer hardware, software, communication devices, or transmissions lines, or data corruptions, theft, tampering, destruction, unauthorized access to or alteration of any participation materials, loss, human error, or otherwise.

Limit 1 Entry per person/email address/day regardless of method of entry.

The odds of winning the Grand Prize (defined below) depend on the total number of Eligible Entries received during the Program Period.

4.2 Drawing:

On or about September 18, 2024, the Sponsor will conduct one (1) random drawing ("Drawing") from among all Eligible Entries received to select one (1) Winner (defined below) of the Grand Prize.

4.3 Prizes:

Grand Prize: One (1) Winner will receive a Grand Prize (1) (the "Grand Prize" or the "Prize") comprised of the following: a) two (2) tickets to MiLB 2024 Triple-A Championship Game currently scheduled to be held in Las Vegas, Nevada on September 28, 2024; (b) Round trip, coach class air transportation for the Winner and one (1) guest (the "Guest") from the major airport nearest the Winner's residence (on an airline and airport as determined by Sponsor in its sole discretion) to Las Vegas, Nevada (the "Host City"); (c) Standard hotel accommodations for two (2) consecutive nights (1 room, double occupancy) for the Winner and Guest in the Host City as such hotel is selected by Sponsor in its sole discretion; (d) one (1) \$250 Visa Gift Card to use for transportation, food, souvenirs, and other incidental expenses; and

(e) a one (1) year supply of C4 Performance Energy® (12 total cases). The Approximate Retail Value (“ARV”) of the Grand Prize is \$2,500.00. There is a total of one (1) Prize.

4.4 Winner Selection and Notification:

The potential winner will be notified within three (3) business days of the Drawing by email at the email address provided with the Entry. Within three (3) days of being notified, the potential winner will be required to complete, sign, and return documentation required by Sponsor, including an Affidavit of Eligibility, release of liability, a publicity release form (except where prohibited), and an IRS Form W-9 or equivalent form with the potential winner’s full social security number or other U.S. taxpayer identification number. You must have a valid social security number or personal U.S. tax identification number to be eligible to win the Grand Prize. Provided that the potential winner is in compliance with the Official Rules and after having successfully proven their eligibility and provided any documentation required by Sponsor, the potential Winner will be determined to be the “Winner”. Sponsor expressly reserves the right to delay the announcement of the Winner for any reason it deems necessary. The Grand Prize will be awarded to the authorized account holder of the e-mail address or telephone number submitted with the Entry regardless of the individual who submitted the winning Entry. If a potential winner cannot be reached after a reasonable effort has been exerted or fails to respond within three (3) days of the date of notification, the potential winner forfeits the Prize, and a first alternate potential winner will be randomly drawn from all remaining Eligible Entries. If the first alternate potential winner is unable to accept the Prize, the Prize is forfeited, and a second alternate potential winner will be randomly drawn from all remaining Eligible Entries. If such a second alternate winner is unable to accept the Prize, the Prize is forfeited and will not be awarded.

The date for fulfillment of the Prize is anticipated to be on or around July 10, 2024; but all subject to change in Sponsor’s sole discretion. If for any reason the Prize or any Prize component is unavailable or the Prize, any Prize component or related event(s) is delayed, cancelled, or postponed, or for any other reason, Sponsor reserves the right to modify the Sweepstakes in its sole discretion and award a substitute prize, or portion of a prize, of comparable or greater value as set forth in these Official Rules. No substitution, transfer, assignment or cash equivalent of the Prize, or any portion thereof, is permitted by the Winner. The Program Entities shall have no responsibility or obligation to the Winner if they are unable or unavailable to, or they do not for any reason, accept or utilize the Prize. The terms and conditions of the tickets awarded as part of the Prize will govern in the event a legal game/event/exhibition, as defined by PDL, is not played or held due to weather conditions, an act of God, an act of terrorism, civil disturbance, or any other reason. Winner and his/her guest(s) agree to comply with all applicable ballpark and venue regulations in connection with the Prize. Sponsor and the PDL Entities reserve the right to remove or to deny entry to the Winner and/or his/her guest(s) who engage in a non-sportsmanlike or disruptive manner or with intent to annoy, abuse, threaten, or harass any other person at the game/event/exhibition. Sponsor and the PDL Entities will not be responsible for weather conditions; acts of God; acts of terrorism; civil disturbances; local, state, or federal regulation, order, or policy; work stoppage; epidemic, pandemic, or any other issue concerning public health or safety; or any other event outside of their control that may cause the cancellation or postponement of any Minor League Baseball game/event/exhibition. Minor League Baseball game/event/exhibition tickets awarded as prizes may not be resold, offered for resale, or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and Prize forfeiture, and may invalidate the license granted by the game/event/exhibition ticket.

NEITHER SPONSOR NOR ANY PROGRAM ENTITY SHALL HAVE ANY LIABILITY FOR ANY PERSONAL INJURIES, DEATH, PROPERTY DAMAGE, OR OTHER DAMAGES OR EXPENSES RESULTING FROM OR ARISING OUT OF OR RELATED TO THE PRIZE OR ANY ACTIVITY RELATED TO THE PRIZE OR ANY OTHER ASPECT OF WINNER'S ACCEPTANCE OR USE OF THE PRIZE.
