Administrator's computer is the official time-keeping device for the Sweepstakes.

Complete the registration form by entering true and accurate information in the required fields (including, First Name, Last Name, Street Address, City, State/Province, Zip/Postal Code, E-Mail, and phone number. Participant will also be prompted to select their pet type (puppy/kitten, cat/dog), the pet's name, age (month/date/year) and pet size (only for puppy). Follow instructions and submit Receipt Image (including reading and accepting any required terms and conditions) to receive: (A) one (1) entry per Participating Product purchased into the applicable Weekly Cat Drawing or Weekly Dog Drawing (a "Weekly Entry") based on the pet type selected during registration, subject to the overall limit set out below (i.e., if you choose a cat, you will be Entered into a Cat Weekly Drawing and if you choose a dog, you will be Entered into a Weekly Dog Drawing); and (B) one (1) entry per Participating Product purchased into the Grand Prize Drawing, subject to the overall limit set out below (a "Grand Prize Entry", and together with a Weekly Entry, an "Entry"). Administrator is an independent judging organization whose decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes.

Non-winning Entries from a Weekly Drawing will carry over into the subsequent applicable Weekly Drawing, if available, and will be included there.

Grand Prize Winner Notification: The potential winner(s) of the Grand Prize will receive a prize notification via email and/or phone call as soon as reasonably practicable after the winner selection, via the contact information provided in their registration form where they may be asked to confirm their intention to be potentially awarded the Prize.
