

"Sun Auto Summer Road Trip Sweepstakes"

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED. VOID OUTSIDE THE ELIGIBILITY AREA (DEFINED BELOW), AND WHERE PROHIBITED OR RESTRICTED BY LAW. The Sun Auto Summer Road trip Sweepstakes ("Sweepstakes") is sponsored by Sun Auto Tire & Service, Inc (the "Sponsor") and is administered by Snipp Interactive Inc (the "Administrator"). The Sponsor's address is 1201 S Alma School Rd # 14000, Mesa, AZ 85210. The Administrator's address is 6708 Tulip Hill Terrace, Bethesda, Maryland 20816. The Sweepstakes begins at 12:01 a.m. Eastern Time ("ET") on June 26, 2024, and ends at 11:59 p.m. ET on September 13, 2024 ("Sweepstakes Period"). The computer clock of Sponsor is the official time-keeping device in the Sweepstakes, and the Sponsor may also rely on the time processing functions of third parties. Sponsor shall have the sole discretion in determining the timeliness of any action or inaction related to this Sweepstakes.

- 1. ELIGIBILITY:** The Sweepstakes is open only to individuals who: (a) are legal residents of Arizona (AZ), Arkansas (AR), California (CA), Florida (FL), Illinois (IL), Iowa (IA), Kansas (KS), Kentucky (KY), Louisiana (LA), Minnesota (MN), Mississippi (MS), Missouri (MO), Nebraska (NE), Nevada (NV), Ohio (OH), Oklahoma (OK), Oregon (OR), Texas (TX), Virginia (VA) or Washington (WA) (the "Eligibility Area"); (b) 18 years of age or older at the time of entering the Sweepstakes; (c) agree to be bound by the terms of these Official Rules; and (d) submit a valid Entry (as defined below) (each such individual, an "Entrant" or "you"). This Sweepstakes is **not open** to Entrants who: (i) are employees, officers, directors, agents and representatives of the Sponsor, or any other entity which is involved in any aspect of the creation, production, operation, execution or fulfillment of the Sweepstakes, (such entities, collectively, the "Sponsor Parties"); (ii) are immediate families (defined as parents, child, sibling, domestic partner, spouse and their respective spouses, regardless of where they reside) or household members (defined as those people who share the same residence at least three (3) months a year) of such individuals listed in clause (i) above); (iii) are prohibited by applicable law from entering the Sweepstakes; or (iv) do not meet any of the eligibility requirements set forth above.

3. HOW TO ENTER: NO PURCHASE NECESSARY. Purchase is not required to enter the Sweepstakes and will not improve your chances of winning.

There are two (2) ways to participate in the Sweepstakes: by making a Qualifying Purchase (defined below) from a Qualifying Retailer (defined below) and submitting your Receipt (as defined below), or by submitting a "No Purchase Entry" (as described below). If the Receipt is verified, you will receive Entry(ies) into the applicable Entry Period based on the total amount of the Qualifying Purchase (after discounts and before taxes) as follows:

Once your valid eligible Non-Purchase Submission has been received in accordance with these Rules, you will receive five (5) sweepstakes Entries. In order to be valid and eligible, the Eligible Non-Purchase Submission must: (i) be received individually in an envelope with sufficient United States postage; (ii) be postmarked on or before the applicable AMOE Postmark Date specified in Table A above and received on or before the applicable AMOE Received Date specified in Table A above; and (iii) contain all of the information listed above. The Sponsor and Administrator take no responsibility for any lost, stolen, delayed, illegible, damaged, misdirected, late or destroyed Non-Purchase Submissions.

Limit of fifteen (15) Entries per household, irrespective of method of Entry, throughout the Sweepstakes Period. Total up to Three valid receipts can be submitted during the sweepstakes period per household. A maximum of five sweepstakes entries will be awarded per valid receipt for the household. There will be three (3) random drawings held in this Sweepstakes, one (1) for each of the Entry Periods. The random drawings will take place on or about the applicable Draw Dates specified in [Table A](#) above, at the Administrator's office in Detroit, Michigan. On each drawing, the Administrator will randomly select such number of winners as specified in [Table A](#) above, from among all eligible Entries received during the respective Entry Period. A total of Thirty-Six (36) Prize winners will be selected in connection with the entire Sweepstakes. The odds of winning a Prize depend on the total number of eligible Entries received during the respective Entry Period. **All non-winning Entries from any Entry Period drawing will be included in the subsequent Entry Period random drawing.**

The administrator will notify the potential winners via telephone or email at the Administrator's sole discretion. Administrator reserves the right, but not the obligation, to attempt to contact any winner(s) more than once, in its sole and absolute discretion, and will not be required to attempt to contact winner(s) an equal number of times or in the same manner.
