Official Rules

The On The Rocks™ Holiday Sweepstakes ("Sweepstakes") is sponsored by Jim Beam Brands Co (the "Sponsor"). The Sponsor's address is 222 W Merchandise Mart Plaza, Chicago, IL, 60654. The Sweepstakes begins at 12:00:01 a.m. Eastern Time ("ET") on October 1, 2025, and ends at 11:59:59 p.m. ET on December 31, 2025 ("Sweepstakes Period"). A day ("Day") shall be defined as beginning at 12:00:01 a.m. ET and ending at 11:59:59 p.m. ET. The computer clock of Sponsor is the official time-keeping device in Sweepstakes, and the Sponsor may also rely on the time processing functions of third parties. Sponsor shall have the sole discretion in determining the timeliness of any action or inaction related to this Sweepstakes.

The Sweepstakes consists of two (2) separate components, a regional component ("Regional Component") and a national component ("National Component"), with each component being open to participation for Entrants residing in specific areas (each a "State") in the United States and/or the District of Columbia (the "Eligibility Area"), all as further detailed in Table A below:

1. **ELIGIBILITY:** The Sweepstakes is open only to individuals who: (a) are 21 years of age or older at the time of entering the Sweepstakes; (b) agree to be bound by the terms of these Official Rules; and (c) submit a valid Entry (as defined below) (each such individual, an "Entrant" or "you"). **In addition, each Regional Component of the Sweepstakes is only open to Entrants who are legal residents of the eligible States as set out in Table A above.** This Sweepstakes is **not open** to Entrants who: (i) are employees, officers, directors, agents and representatives of the Sponsor or any entity which is involved in any aspect of the creation, production, operation, execution or fulfillment of the Sweepstakes, (such entities, collectively, the "Sponsor Parties"), or any alcohol beverage licensees (including alcohol beverage suppliers, wholesalers, distributors or retailers); (ii) are immediate families (defined as parents, child, sibling, domestic partner, spouse and their respective spouses, regardless of where they reside) or household members (defined as those people who share the same residence at least three (3) months a year) of such individuals listed in clause (i) above); (iii) are prohibited by applicable law from entering the Sweepstakes; or (iv) do not meet any of the eligibility requirements set forth above.

If you do not have a QR reader already installed on your phone, type "QR reader" in your mobile device's application store search field to find available QR readers for your smart phone or other web-enabled device. You will receive a response which will contain a link to download a QR reader for your specific device. Check with your wireless service provider for details on these and other applicable charges. Participants are solely responsible for any such wireless charges. Not all wireless carriers participate.

Limits: The following limits apply throughout the Sweepstakes Period, regardless of method of Entry.

a. Entrants who are residents of a state that is a Regional Component State can receive a maximum of (per person, per email address):

3. WINNER SELECTION; DRAWINGS: There are a total of two (2) drawings (each, a "Drawing") for the Sweepstakes as follows:

- **Regional Component Drawing:**

On or about January 5, 2026, the Sponsor will randomly select such number of winners in **each** Regional Component State as set out in Table A above, from among all eligible Entries received during the Regional Component Entry Period from Entrants residing in each such Regional Component State (total of 31 winners).

- **National Drawing:**

On or about January 5, 2026, the Sponsor will randomly select ten (10) winners from among all eligible Entries received during the National Component Entry Period from Entrants residing in the National Component States.

Odds of winning a Regional Component Prize (defined below) depend on the number of eligible Entries received during the applicable Regional Component Entry Period from residents of the applicable Regional Component State.
